

## 1994 ORDINANCES

- 1372 AUTHORIZING THE ISSUANCE AND SALE OF WATER AND SEWER REVENUE REFUNDING BONDS OF THE CITY IN THE PRINCIPAL AMOUNT OF \$2,035,000 FOR THE PURPOSE OF PROVIDING FUNDS TO REFUND A PORTION OF THE CITY'S WATER AND SEWER REVENUE BONDS, 1985 AND 1987; PROVIDING THE COVENANTS, TERMS, AND CONDITIONS UNDER WHICH SUCH BONDS SHALL BE ISSUED; PROVIDING FOR THE PURCHASE OF OBLIGATIONS TO EFFECT SUCH REFUNDING; AND APPROVING THE SALE OF SUCH BONDS
- 1373 AMENDING THE GRANDVIEW MUNICIPAL CODE SECTION 15.16.010 ADOPTING THE 1991 EDITION OF THE UNIFORM SIGN CODE

- 1378 VACATING A PORTION OF ACOMA STREET AND APACHE DRIVE
- 1379 ADOPTING THE WASHINGTON MODEL TRAFFIC ORDINANCE AS PROVIDED IN THE WASHINGTON ADMINISTRATIVE CODE CHAPTER 2.08-330 AND REPEALING GRANDVIEW MUNICIPAL CODE CHAPTER 10.04
- 1380 AMENDING CHAPTER 17 OF THE GRANDVIEW MUNICIPAL CODE RELATING TO CHILD DAY CARE BUSINESSES ALLOWING FAMILY DAY-CARE PROVIDERS HOME FACILITY IN RESIDENTIAL AND COMMERCIAL DISTRICTS
- 1381 AMENDING CHAPTER 3.76, GRANDVIEW MUNICIPAL CODE POLICE DEPARTMENT SERVICE FEES
- 1382 AMENDING THE GRANDVIEW MUNICIPAL CODE AND PROVIDING THAT ALL PENALTIES SHALL CONFORM TO STATE LAW PENALTIES FOR SIMILAR OFFENSES
- 1383 AMENDING CHAPTER 12.04 OF THE GRANDVIEW MUNICIPAL CODE REGARDING "SIDEWALK MAINTENANCE"
- 1384 PROVIDING FOR THE ANNEXATION OF CERTAIN REAL PROPERTY TO THE CITY OF GRANDVIEW, PURSUANT TO THE PETITION METHOD, AND INCORPORATING THE SAME WITHIN THE CORPORATE LIMITS THEREOF, PROVIDING FOR THE ASSUMPTION OF EXISTING INDEBTEDNESS, REQUIRING SAID PROPERTY TO BE ASSESSED AND TAXED AT THE SAME RATE AND BASIS AS OTHER PROPERTY

WITHIN SAID CITY, ADOPTING A COMPREHENSIVE LAND USE PLAN, AND CHANGING THE OFFICIAL ZONING MAP OF THE CITY.

- 1392 FIXING THE AMOUNT OF THE REGULAR AND EXCESS TAX LEVY NECESSARY TO RAISE THE MONIES TO MEET ESTIMATED EXPENDITURES AND DEBT SERVICE FOR VOTED GENERAL OBLIGATION BONDS OF THE CITY OF GRANDVIEW FOR THE ENSUING YEAR 1995 LEVIED UPON THE REAL AND PERSONAL PROPERTY OF THE CITY OF GRANDVIEW
- 1393 APPROPRIATING FUNDS FOR THE PURCHASE AND INSTALLATION OF WATER VALVES WITHIN THE IRRIGATION FUND AND AMENDING THE 1994 ANNUAL BUDGET
- 1394 AN ORDINANCE OF THE CITY OF GRANDVIEW, WASHINGTON, AMENDING CHAPTER 2.86.050 AND ADDING SECTION 2.86.090 TO THE GRANDVIEW MUNICIPAL CODE RELATING TO LEGAL REPRESENTATION FOR CITY EMPLOYEES AND OFFICIALS
- 1395 CHANGING THE ZONING CLASSIFICATION OF CERTAIN LANDS AND AMENDING THE ZONING MAP OF THE CITY OF GRANDVIEW (PAULSON REZONE)
