IMPORTANT:

The Parade route will start at the Harriet Thompson Elementary School located at 1105 W. 2nd Street (at the corner of 2nd Street and Euclid Street) and will end at a parking lot located at South Elm Street. The Parade Registration Desk will be located at 1105 W. 2nd Street in front of the Harriet Thompson Elementary School.

YAKIMA VALLEY FAIR PARADE RULES

- 1. All Parade entry registration forms must be received by the Grandview Chamber of Commerce by August 1, 2014 if your entry is to be judged. All entries that submit Parade entry registration forms to the Grandview Chamber after August 1st will **NOT BE JUDGED**. Any Parade entry not present and registered by 3:00 p.m. on the day of the Parade, August 7, 2014, is welcome to participate in the parade, but will be placed at the end of the parade line-up.
- 2. <u>All</u> entries must check in at the registration table prior to being allowed into the unloading or staging area. The Parade registration table will be located at 1105 W. 2nd Street in front of the Harriet Thompson Elementary School. After you have been issued your parade entry number, you will be directed into the unloading or staging area.

FLOAT ENTRIES: After checking in at the registration table, please unload your float at the bus barn located next to the Harriet Thompson Elementary School. ALL QUEENS AND COURTS SHOULD BE IN PLACE FOR JUDGING BY NO LATER THAN 4:30 p.m.

HORSES should be unloaded next to the SCHOOL BUS GARAGE. Judging will begin at 4:30 p.m. for those horse entries pre-registered by 3:30 p.m. A water trough will be available next to the Middle School Parking lot.

ALL OTHER ENTRANTS must assemble their entries AFTER CHECKING IN AT THE REGISTRATION TABLE.

- **3.** All judging will begin promptly at 4:30 p.m. Any Parade entry not registered and in place when the judge passes by a particular Parade entry location will not be eligible for an award. Awards will be presented prior to the start of the parade.
- 4. No candy, leaflets, food, pencils, or other items may be THROWN from the Parade entries at any time. HOWEVER, candy, leaflets or other items may be HANDED OUT directly to people along the Parade route under the following circumstances: A minimum of one person must be on each side of the entry, at the outermost edges of the street at ALL TIMES, to pass out items to spectators. Absolutely no water guns, water balloons, or any kind of water throwing will be allowed or tolerated! You will be removed from the parade line-up if you engage in any of these activities, and there will be NO EXCEPTIONS TO THIS RULE!
- **5.** Restrooms will be available in the staging area at the Grandview Middle School.
- **6.** *PARADE OFFICIALS* will be wearing identification badges and can be contacted for information and assistance.
- 7. CONSUMPTION OF ALCOHOL IN THE STAGING AREA, ON THE PARADE ROUTE, OR AT THE END OF THE PARADE ROUTE IS STRICTLY PROHIBITED!!
