# A. Resolution approving the final plat of Grandridge Estates – Phase 2 on Grandridge Road

City Administrator Arteaga explained that at the March 24, 2020 meeting, Council adopted Resolution No. 2020-13 approving the Grandridge Estates Subdivision 227-lot preliminary plat. Following approval of the preliminary plat, the developer proceeded with the infrastructure improvements for Grandridge Estates subject to the conditions as outlined in the Hearing Examiner's report and per Grandview Municipal Code Section 16.24 Design Standards and Section 16.28 Improvements. Phase 1 consisting of 25 lots was approved by the Council on September 8, 2020. The infrastructure improvements for Grandridge Estates Phase 2 consisting of 47 lots was completed to the City's standards. The final plat map for Phase 2 was presented.

### C. Neighborhood Focus - Code Enforcement Violations

Code Enforcement Officer Taylor provided Code Enforcement/Building Department statistics from 2011 to October 31, 2020 regarding nuisance activities, permit activities, permits issued, property violation notices served, notice and orders served, violations abated, cross connection program notices, business license inspections and backflow units tracked.

Police Chief Fuller explained that in an effort to more efficiently coordinate code enforcement efforts and address quality of life issues, the Neighborhood Focus program was started. On the first Tuesday of each month, a Police Officer and Code Enforcement Officer focus on a different area of the City. The City was divided into six areas and over the course of a year, all six areas of the City would be focused on at least one to two times. Once in that area, the Code Enforcement Officer would focus on code enforcement/building issues and the Police Officer would focus on parking violations, blocked alley, etc. Many properties have violations that either Code Enforcement (CE) or Police Department (PD) have sole jurisdiction. This program allowed for CE and PD to be in the same area at the same time which improved efficiency. A Neighborhood Focus flyer was created to explain the program to citizens and provide information on who to call for non-police issues. In reality, this was no different than what CE and PD do on a regular basis. The program provided CE and PD a chance to highlight a program that generates interest in neighborhoods and showed that the City was trying to focus on things that were important to neighborhoods.

Discussion took place. This was for information purposes only and no action was taken.

#### D. Community Website Development

At the October 27, 2020 Council meeting, Mayor Mendoza appointed Councilmembers Ozuna and Everett to work with the City Administrator and staff to update the City's website.

Councilmember Ozuna presented a Community Website Mission and Purpose statement. The mission was to design a dynamic, attractive and interactive website for the Grandview community. The purpose was: To serve the informational needs of residents, businesses, and community members; To market to potential new businesses; To better inform residents about key City events, dates, activities and other relevant information; To better engage residents to participate in the City's public meetings, Council meetings, commissions and committees. He distributed a timeline with tasks for the website development and a draft community website survey. He requested Council review the information and provide feedback.

#### A. Ambulance Service Utility Fee

Following discussion at the October 27, 2020 C.O.W. meeting regarding the implementation of an ambulance service utility fee, staff was advised by the City Attorney that the City would need to conduct a cost of service study to determine the total costs necessary to regulate, operate and maintain the ambulance utility. The Fire Chief was in the process of conducting a cost of service study, however, the study would not be complete by the time the 2021 Annual Budget would need to be adopted (12/31/2020).

In order to adopt a balanced budget, Councilmember Everett recommended Council authorize the City Treasurer to allocate \$170,000 from the Current Expense Fund to the Emergency Medical Services (EMS) Fund. It was anticipated that the steps necessary to implement an ambulance service utility fee should be finalized by March 2021 and the remaining balance allocated to the EMS Fund to fund ambulance services would be transferred back to the Current Expense Fund through a budget amendment once the fee was implemented.
