A. <u>Community Survey Results – BERK Consulting</u>

Dawn Couch with BERK Consulting presented the Grandview COVID-19 Community Survey results. She explained that the purpose of the survey was to gather community information and stakeholder input to support the development of ARPA grant proposals to fund improvements to the Grandview community's economy and quality of life; to improve understanding of the impacts of COVID-19 on the community; and to inform priority for actions the City can take. Online and paper surveys in English and Spanish were distributed. 505 responses representing 7% of Grandview adults were received. Responses were gathered between March 7 and April 8, 2022.
