AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the City of Grandview from January 1, 2021 through December 31, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the City's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2022 and 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Cash receipting timeliness and completeness of deposits at City Hall
- Procurement professional services, public works and purchases
- Accounts payable general disbursements and electronic fund transfers
- Police Department citation reconciliations
- Contract compliance Supporting Investment in Economic Diversification (SIED) Loan
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE CITY

The City of Grandview, incorporated on September 21, 1909, is a growing community of approximately 11,000 citizens in Yakima County. The City provides services including a domestic water system, a wastewater treatment plant, an irrigation system and curbside garbage service. Additionally, the City offers police services, fire prevention and suppression services, parks and recreation programs and a large public works department. The City provides several facilities including a cemetery, library and community center.

An elected, seven-member Council and a separately elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its roughly 55 full-time and 20 seasonal employees. The City operated on an annual budget of approximately \$22.6 and \$24.1 million and 2021 and 2022, respectively.
